Native prairie flowers, clover, and other pollinator-friendly species are vital in creating and maintaining the habitats many species like honeybees, butterflies, and natives bees depend on. The Stearns County SWCD Pollinator Habitat Program provides free, high-quality seed along with technical assistance to help restore and maintain habitats for many years to come.





Native Bees continue steep declines in both habitat and population.



Monarch Butterfly population has decreased by **80%** in the last 20 years.



Honeybees lose **40%** of the hive annually.



More than 150 crops in the U.S. depend on pollinators, including many fruit crops.

# WHAT IS THE POLLINATOR HABITAT PROGRAM?

The Stearns County Pollinator Habitat Program provides assistance in establishing pollinator communities on lands that do not qualify for the USDA Conservation Reserve Program (CRP). By restoring, conserving, and increasing the diversity of pollinator plant communities, it provides a place that many species like honeybees, butterflies, and native bees depend on.

## WHY IS IT IMPORTANT TO PARTICIPANT?

Pollinators such as the monarch butterfly, the honeybee, and native bees across the state are decreasing. By providing habitat for rare and declining wildlife species, landowners can contribute to providing a source of food and shelter for our most important pollinators.



## WHO QUALIFIES?

- Landowners in Stearns County
- Private, public, and corporate lands
- Minimum project size is 2 acres
- Lands not eligible for USDA CRP

# **CONTRACT REQUIREMENTS**

- Contract length is 10 years
- \$300 (flat rate) will be paid per acre
- The seeding must be completed between May 15-June 30 or after November 1
- Project details must follow SWCD guidelines



- The SWCD may perform site inspections at any time of the contract life. Inspections will typically occur prior to seeding, during year of establishment for practice certification, and subsequently in years three, five, and nine
- If the title of the land is sold or transferred to another party before the expiration of the ten-year contract, it shall be the responsibility of the new owner
- Free technical assistance will be provided by the Stearns County SWCD
